7. Ensure fees are paid on or before the due date, except when special arrangements are made through the Principal/General Manager.
8. Authorise the school authority and staff that for the time the student is on the school grounds or engaged in official school activities, whether in school or otherwise, the student is under the care and control of the College Principal or teaching staff. Such authorisation shall enable the Principal or delegated staff to take such action as deemed necessary to correct attitude and/or behaviour.
9. **Understand that the College may suspend or terminate enrolment at its discretion for failure to comply with these conditions or other breaches of the school's rules and regulations. Such termination may be for a singular serious incident or for the failure over a period of time to correct less serious breaches.**
